

- 5. At this R. C. Goswami got angry with Sri J.K. Das, DCF and left the meeting uncompleted suddenly.
- 6. Sri A. Ali ,DCF and Sri K.K. Bora, DCF requested Sri R.C. Goswami to be seated and make the matter settled. The Additional Principal Chief Conservator of Forests from the

chair also requested Sri R.C. Goswami to be seated and complete the discussion of the meeting but Sri R.C. Goswami left the meeting uncompleted.

### Section 7(5):

(ii) Price fixed for printed publication at Printed Price or Rs.2/- per page of photocopy for extracts from the publication

- (a) No fee prescribed under Section 6(1), 7(1) and 7(5) shall be charged from the persons who are of below poverty line as may be determined by the State Government as stipulated under Section 7(5) of the Right to Information Act, 2005.
- (b) No fee prescribed under Section 7(1) and 7(5) shall be charged where the "State Public Information Officer" fails to provide information within the time limits prescribed under Section 7(1) as stipulated under Section 7(6) the Right to Information Act, 2005.

The above fees shall be collected in form of Demand Draft or Banker's Cheque or cash against proper receipt to be issued by an officer authorized in this behalf by the State Public Information Officer or the Assistant State Public Information Officer as the case may be and shall be deposited through Treasury Challan under the Head of Account "0070 other Administrative Services".

### Inquiry report on the Allegation put by Shri R.C Goswami, IFS(Retd.) against Shri N.K Sahani and his Co-RETs

As ordered by the Principal Chief Conservator of Forests (Social Forestry). Assam, vide 0.0 No.342dtd.12/10/2016 communicated under cover of his Memo No. SFD/ Confidential/ NBMMP/2016-17, dtd.12/10/2016 to inquire into the allegations filed by Shri R.C Goswami, Conservator of Forests(Retd.) on the matter of embezzlement and misappropriation of subsidy amount by N.K Sahani and his Co-RETs under National Biogas and Manure Management Programme(NBMMP) is initiated by the undersigned and the findings are elaborated as under.

We have been given to inquire 4 nos. of allegation filed by Sri Goswami. These are mostly similar and identical with one another stating fraudulent drawl, embezzlement and misappropriation of subsidy amount by N.K Sahani and his Co-RETs when they installed the bio-gas plants across Assam. We have examined the points of allegation one by one as follows.

### Allegation No.1, dtd.31/8/2016

Sub: Large scale fraudulent drawal of Govt. money by N.K Sahani, RET and his Co-RETs.

In this allegation the petitioner alleged that Shri N.K Sahani and Co-RETs do not construct even 10% of biogas plants. They repair earlier biogas plants constructed by Khadi and Village Industry Commission and also plants of Forest Department and change the name of beneficiaries as well as villages.

Findings: The petitioner did not mention name of a single beneficiary out of 90% of non doing plants which have been fraudulently shown in old plants of Khadi and Village Industry and of Forest Department as alleged. So the field inspection cannot be carried out as it is not specific. Actually, the fact is that 100% field inspection is done in division level and after that 10% inspection is done randomly in Principal Chief Conservator of Forests (Social Forestry) level, there is least chance of happening fraudulency. So, large scale fraudulent drawl of Govt. money is false.

Hence, the allegation is ill defined, fake and motivated.

### Allegation No.2, dtd.12/9/2016.

Sub: Embezzlement and Misappropriation of subsidy amount by N.K. Sahani and his Co-RETs.

In this allegation Sri Goswami stated that Bio Gas scheme is a C.S. Scheme where 90% of the plant cost is given to the beneficiary as subsidy. Astonishingly subsidy amount is given to Sri.N.K. Sahani and his Co-RETs and they give a very nominal portion of the subsidy to the beneficiaries where they constructed Bio-gas plants practically (ie.10%).

Findings: This statement of allegation is totally false. From the office records, present Bio-gas plant estimate is like this.

Beneficiary Cost- Rs. 21. 540.00(66%)

Subsidy <u>Rs.11, 000.00(34%)</u>

Rs.32, 540.00

Contd-2

In this scheme beneficiary has to procure himself requisite amount of bricks, stone chips and sands which probable cost Rs. 21,540,00. RET is to supply cement for construction of plant along with masonry cost. Besides he has to supervise the whole construction works as a rural energy technician so that the plant becomes successful. After that he supplies gas stove and other necessary accessories to complete the plants. Cost of RET part which is coming from subsidy amount is Rs. 11,000.00. This process has been continuing from the inception of Bio-gas scheme. Hence the allegation is fake and baseless.

Allegation No.3 dtd.16/09/2016.

Embezzlement of Govt money by Sri N.K. Sahani under Bio-Gas scheme by benami. Sub:-

The Petitioner here alleged that:

1) Sr N.K. Sahani is taking allotment of Bio-gas plant in the name of his kith and kin to escape from the criminal offence.

This point of allegation could not be understood. What type of criminal offence was rendered by Sri N.K. Sahani and how could he save himself by taking the allotment of Bio-gas plant in the name of his kith and kin is not given by the petitioner. It is known that the Bio-gas plants are allotted to RETs by the respective DFO cum CEO for his division.

II) Besides this there is another point of allegation that Sri N.K. Sahani is trapped in offence of benami transaction. If the accounts of those benami RETs are examined it will be quite clear that there was a benami transaction.

This is also a vague Statement put by the petitioner. How can there be a benami accounts holder in a Government Bank? What does it mean by benami transaction? The petitioner did not mention any name of benami RETs or dummy RET in support of his allegation. So, the allegation is ill defined and motivated.

Sub:- Embezzlement of Govt. money by Sri. N.K. Sahani under Bio-gas scheme by benami transaction in the name of dead person, without submitting voter ID or copy of Bank pass book of beneficiary or GPS co-ordinates.

In this petition Sr Goswami alleged that Sri.N.K. Sahani had taken allotment of Bio-gas plants in the name of his brother S.K. Sahani who had died long back and made benami transaction in the name of dead person copying his signature with the help of Forest officials.

From the office records, statement of Sri N.K. Sahani and that of Sri P. Chakraborty, accountant, it is known that S.K. Sahani was a Rural Energy Technician who got allotment of 150 Nos. Bio-gas plants to install across the Nagaon Division for the year 2014-15 which were to be completed latest by March/15. In the month of July/2015 after completion of the Bio-gas plants S.K. Sahani suddenly fell sick and handed over a power of attorney along with a general voucher signed by him(issued on 7/07/2015) to Sri N.K. Sahani to deal with all kinds of monetary transaction that were related to the Bio-gas plants and went to Bihar for treatment. Sri N.K. Sahani submitted this to the APCCF (SF) Assam accordingly.

On 11/09/2015 Sri N.K. Sahani received an account payee cheque for work done of 150 nos of Bio-gas plant in Nagaon FDA in the name of S.K. Sahani from the APCCF (SF) Assam and deposited the same in the Bank. After few days when the cheque was formally credited to the bank A/c of S.K. Sahani the son of his brother informed N.K. Sahani that his father was no more. Being asked Sri N.K.Sahani replied that he could not recollect the date death of S.K. Sahani

Here it is found that S.K. Sahani had completed his allotted works before going to home in Bihar. He was to receive the payment for his work done under Nagaon FDA. Sri N.K. Sahani just collected the cheque on behalf of S.K.Sahani and deposited same in the bank account of S.K. Sahani. As the cheque was a/c payee, bank credited the amount of the cheque to the a/c of S.K. Sahani not to the a/c of N.K. Sahani. In scrutiny of the office records, no where it was found that N.K. Sahani copied the signature of his brother S.K. Sahani as alleged and no forest official helped him in this regard.

Hence, Embezzlement of Govt. money by benami transaction by N.K. Sahani is false and

In view of the above it is observed that the allegations put by Sri R.C.Goswami (Retd.CF) the allegation is not worthy. bear no value. As no allegation is having any specific point to be inquired, so these are all fake and baseless and N.K. Sahani cannot be made guilty by this.
